Volltext	<p>Deregistration must be notified in writing to the principal either by the legal guardians or by the pupil themselves once they have reached the age of religious majority (from the age of 14). If minors withdraw from religious instruction, their legal guardians must be informed. The exemption from religious instruction cannot be tied to specific dates. If the declaration is revoked, the obligation to attend religious instruction continues to apply. If there are sufficient grounds for assessment, a grade will be awarded. For school organizational reasons, the school may limit renewed attendance to the beginning of a school semester.</p>

For pupils under the age of 14, this is decided by the parents. The school is responsible for the supervision of pupils who do not take part in the school church service. Religious festivals in everyday school life offer children and young people a variety of opportunities to celebrate in community. Participation in such religious events is voluntary, irrespective of participation in religious education.
