Teaser	You have the option of registering at a music school and taking advantage of the courses and instruments on offer there in the form of music lessons.
Volltext	Music schools are educational institutions whose main tasks are to provide a basic musical education, to train the next generation of amateur and amateur musicians, to identify and promote talented students and to prepare them for professional studies. You can use a digital application assistant to enrol at a public music school. Once the application has been completed and submitted, you will receive confirmation of your enrollment from the music school. A teaching contract only comes into effect after you have made an appointment, been allocated a lesson and received confirmation of admission from the music school. As a rule, the music school will appoint the teacher.
Erforderliche Unterlagen	Proof of prior knowledge, if applicable Proof of receipt of benefits, if applicable
Voraussetzungen	You don't need to have any previous musical knowledge to start at a music school. The necessary knowledge is taught in the lessons.  However, admission to individual types of lessons may be made dependent on proof of certain prior knowledge or an aptitude test. Minors must be registered by a legal representative.
Kosten	Fees are charged for lessons at music schools and for the provision of musical instruments, which are set out in the music school fee regulations. School fees can be reduced or waived on application. The fee statutes regulate the possibility of reductions: for example, several children from the same family, generally eligible families or recipients of benefits according to
