Teaser	You may apply for an exemption from the permit requirement to purchase and possess ammunition.
Volltext	In principle, you need a permit for the acquisition and possession of ammunition. Deviating from this, there are specifically named exceptions. In addition, you have the possibility to apply for an exception in individual cases, provided that there are special reasons and concerns of public safety and order are not opposed. However, this is only possible for cases that are comparable with the specifically named exceptional cases.
