foundations in accordance with Section 15 (3) of the Foundation Act for the State of North Rhine-Westphalia (StiftG NRW)

Voraussetzungen

- The amendment to the foundation statutes must have been approved by the responsible foundation bodies
 - The articles of association must not contain any provision that precludes an amendment to the articles of association
 - The amendment to the foundation statutes may only impair the permanent and sustainable fulfillment of the foundation's purpose if it can be proven that the circumstances have changed significantly
 - The amendment to the articles of association must not jeopardize the common good
 - The amended articles of association must correspond to the founder's intentions as set out in the foundation deed
 - In the case of an ecclesiastical foundation, the approval of the ecclesiastical supervisory authority is required
 - In the case of foundations in accordance with Section 15 (3) of the Foundation Act for the State of North Rhine-Westphalia (StiftG NRW), you require the approval of the relevant specialist department
 - For savings bank foundations, depending on the wording of the statutes, you may require the approval of the administrative board of the savings banks

\\- Notification of a minor amendment to a foundation statute to the competent foundation authority: within one month of the resolution being passed \\- Entry into force of a material amendment: upon notification of the approval notice
