Volltext	<p>You have an obligation to notify the authorities,</p> <ul style="list-style-type: none"> <li>• if the rent/charge (excluding heating costs) is reduced by more than 15 percent,</li> <li>• if the income of the household members increases by more than 15 percent,</li> <li>• if the number of household members decreases,</li> <li>• if one or more household members apply for or receive transfer benefits (unemployment benefit II, social benefit, basic income support),</li> <li>• if a single household member dies (notification by the heirs or guardians).</li> </ul> <p>The changes can lead to a reduction or, if necessary, to the complete elimination of housing benefit.</p> <p>If you are already receiving housing benefit, you can submit a new application for higher housing benefit,</p> <ul style="list-style-type: none"> <li>• if your total income has decreased,</li> <li>• the number of household members to be taken into account has increased or</li> <li>• your rent or housing costs have increased.</li> </ul> <p>These changes can, but do not necessarily have to, lead to an increase in housing benefit.</p>

<b>Voraussetzungen</b>	<p>Prerequisites for an increase in housing benefit are</p> <ul style="list-style-type: none"> <li>• a reduction in income of more than 15%,</li> <li>• an increase in the number of household members</li> <li>• an increase of more than 15% in the rent or the cost of home ownership.</li> </ul> <p>These changes can, but do not have to, lead to an increase in housing benefit.</p> <p>For details, please contact your local housing benefit office.</p>
<b>Kosten</b>	none
<b>Verfahrensablauf</b>	<p>Please inform your housing benefit authority of any changes to your financial situation.</p> <p>You can also apply for increased housing benefit at your local housing benefit office. The requirements for this entitlement will be checked.</p>
<b>Bearbeitungsdauer</b>	<p>Housing benefit is increased from the date of application. A retroactive increase in housing benefit is generally not possible.</p>
