Volltext	If your total income has increased • your total income has increased, • the number of household members to be taken into account has decreased or • your rent or the burden of home ownership has decreased, the housing benefit authority is obliged to recalculate your housing benefit entitlement. Changes can, but do not necessarily have to, lead to an increase in housing benefit. The increase in housing benefit takes place from the time of the change in circumstances, i.e. also retroactively if necessary.
Erforderliche Unterlagen	The following documents must be enclosed: • Proof of income (salary certificate, pension statement, etc.), • Rental agreement or documents on the costs of the

	residential property you use, if you are its owner. Proof of the change that has occurred.
Voraussetzungen	Prerequisites for a recalculation of the housing benefit are the not only temporary, i.e. lasting more than two months • an increase in income of more than 15%, • a reduction in the number of household members, • a reduction of more than 15% in the rent or the burden of home ownership.
Kosten	none
Verfahrensablauf	The recalculation is carried out ex officio. You are obliged to inform the housing benefit authority immediately of any changes that could lead to a reduction in housing benefit After checking the changes that have occurred, the housing benefit authority will issue a decision.
Bearbeitungsdauer	
Frist	The housing benefit is recalculated from the date of the change in circumstances. Retroactive recalculation of housing benefit is possible.
weiterführende Informationen	In order to avoid or uncover unlawful claims for housing benefit, the housing benefit authority may regularly check the household members by means of a so-called data comparison.
