Volltext	<p>If your total income has increased</p> <ul style="list-style-type: none"> • your total income has increased, • the number of household members to be taken into account has decreased or • your rent or the burden of home ownership has decreased, <p>the housing benefit authority is obliged to recalculate your housing benefit entitlement. Changes can, but do not necessarily have to, lead to an increase in housing benefit.</p> <p>The increase in housing benefit takes place from the time of the change in circumstances, i.e. also retroactively if necessary.</p>
Erforderliche Unterlagen	<p>The following documents must be enclosed:</p> <ul style="list-style-type: none"> • Proof of income (salary certificate, pension statement, etc.), • Rental agreement or documents on the costs of the

	<p>residential property you use, if you are its owner.</p> <p>Proof of the change that has occurred.</p>
<p>Voraussetzungen</p>	<p>Prerequisites for a recalculation of the housing benefit are the not only temporary, i.e. lasting more than two months</p> <ul style="list-style-type: none"> • an increase in income of more than 15%, • a reduction in the number of household members, • a reduction of more than 15% in the rent or the burden of home ownership.

<p>Verfahrensablauf</p>	<p>The recalculation is carried out ex officio. You are obliged to inform the housing benefit authority immediately of any changes that could lead to a reduction in housing benefit</p> <p>After checking the changes that have occurred, the housing benefit authority will issue a decision.</p>
<p>Bearbeitungsdauer</p>	
<p>Frist</p>	<p>The housing benefit is recalculated from the date of the change in circumstances. Retroactive recalculation of housing benefit is possible.</p>
<p>weiterführende Informationen</p>	<p>In order to avoid or uncover unlawful claims for housing benefit, the housing benefit authority may regularly check the household members by means of a so-called data comparison.</p>
