For example, with the city pass you can receive discounts on admission fees and contributions to public facilities such as libraries, music schools, zoos, etc. The city pass is a voluntary service that is not offered by every municipality. You can apply for it in the town |
| | or municipality where you have your main residence. Depending on the municipality, you can apply at the social welfare office, family office or citizens' center, for example. |
