Volltext	In the non-private sector, you must pay a broadcasting fee for each business premises and for motor vehicles used for business purposes, taking into account the number of all employees. To do this, you must register with the competent authority. If this information changes over time, you must notify the competent authority of any changes. Further information can be found in the information material from the Beitragsservice.

Voraussetzungen	• You are the owner of a business premises or have motor vehicles that are subject to contributions.
Kosten	The fee to be paid depends on the number of employees in addition to the holder.
Verfahrensablauf	Registration with the competent authority is unsolicited. As soon as the information you provided during registration changes, you must notify the competent authority.

- last address of the fee debtor as reported to the regional broadcasting corporation
- full name of the owner of the establishment

- Information on sector or establishment affiliation
- Number of hotels, guest rooms and vacation apartments subject to contributions
