These include changes</p> <ul style="list-style-type: none"> <li>• which may be important for the claim or</li> <li>• about which you have made declarations in connection with the advance maintenance payment.</li> </ul> <p>You must report the changes immediately (without undue delay).</p> <p>Examples of changes:</p> <ul style="list-style-type: none"> <li>• Your child no longer lives with you.</li> <li>• You move house.</li> <li>• You get married.</li> <li>• You move in with the other parent.</li> <li>• The other parent pays maintenance again or wants to pay maintenance again.</li> <li>• You become aware of the previously unknown whereabouts of the other parent.</li> </ul> |

- The other parent has died.
- The child has died.
- The child no longer attends school.
- The income of the child who no longer attends school changes because, for example, the amount of the training allowance changes.

Notifications to other authorities are not sufficient.

  - Single parent marries
