Teaser	Injured parties who are resident or ordinarily resident abroad can, under certain conditions, receive reimbursement of the costs of necessary medical treatment for recognized consequences of injury. You can find out more about this here.
Volltext	<p>If you live abroad and required medical treatment there due to recognized consequences of injury, you can receive reimbursement of costs under certain conditions.</p> <p>The benefits will only be provided if these needs cannot be covered by existing statutory or private insurance or state benefits.</p> <p>For example, if your health insurance abroad only covers part of the costs of medical treatment, you may be able to have another part of the costs reimbursed.</p> <p>Please note that your regional association (LVR or LWL) will decide whether and to what extent you will receive support.</p>

Verfahrensablauf	<p>When you apply for social compensation benefits, the Landschaftsverband responsible for you (Landschaftsverband Rheinland or Landschaftsverband Westfalen Lippe) will check whether you are entitled to reimbursement of the costs of medical treatment if you are resident or ordinarily resident abroad. You will receive a notification of the decision and, if applicable, information on the benefits granted as well as other necessary documents.</p> <p>Responsibility: The competent authorities are the pension offices or state social welfare offices. - We will then discuss with you whether you are entitled to social compensation benefits and what support services can be offered.
- If necessary, the case management team can discuss the further procedure and possible entitlements to benefits with you that go beyond the general duty to provide information and advice.
- If you are entitled to social compensation benefits, your contact person will discuss the next steps with you.
- The contact person will provide you with the relevant documents. If necessary, complete the documents, enclose the required evidence or supporting documents and send the documents back to the Landschaftsverband responsible for your application.
- Your entitlement will be determined ex officio on the basis of the documents. The authority will inform you of the result in the form of a decision, which is usually sent to you by letter.
- If entitlements to benefits have been determined, you will receive an approval notice. If no entitlements are determined, you will receive a rejection notice.
- However, you also have the option of submitting the application online. To do this, you must complete the online application and upload the necessary supporting documents.
- The eligible costs and approved cash benefits will be transferred to the account you have specified.
