A person can only ever have one main residence.</p> <p>The main dwelling is the dwelling you use most, i.e. the dwelling where you stay most often. If you are married and do not live permanently apart from your family, this is the family's predominantly used dwelling. The same applies to registered civil partnerships. Minors have their main residence in the predominantly used home of the person entitled to custody. If the persons entitled to custody live separately, the main residence of the minor is the residence predominantly used by one of the persons entitled to custody.</p> <p>The determination of the main residence has important consequences, for example, the jurisdiction of many authorities is based on this and you exercise your right to vote there.</p> |
