Volltext	If you move out of a secondary residence in Germany and do not move into a new residence, you must deregister for this residence.
Erforderliche Unterlagen	The following documents are required: • Identity documents of the persons to be deregistered.
Voraussetzungen	The following requirements must be met: • You are moving out of a secondary residence in Germany for good and • You are not moving into a new home.

Verfahrensablauf	The deregistration procedure is as follows: In person: • You go to the relevant authority and fill out a registration form. • You present the identity documents of the person to be deregistered.

Sachverhalt

- You will then receive the official confirmation of registration from the registration office.

In writing:

- You inform the registration office of the extract with the completed registration form.
- You enclose copies of the ID cards of the persons to be deregistered.
- You will receive the official confirmation of registration by post from the registration office.

Electronically:

- If electronic access has been set up by the registration authority, you can also deregister electronically.

Deregistration deadline (from moving out): within 2 weeks. Deregistration (possible at the earliest): one week before moving out.

- Deregistration of secondary residence
- if you move out of a secondary residence, this secondary residence must be deregistered unless you move into a new residence
- no fees
- Deadline: at the latest within 2 weeks of moving out, at the earliest one week before moving out
- Responsible: Registration authority responsible for the main residence or the now sole residence
