| Teaser | As a citizen of the European Union living in Germany, you can vote in the European elections if you are registered on the electoral roll. |
| Volltext | If you are a citizen of the European Union living in Germany and wish to take part in the European elections, you must first be entered in the electoral register. This happens either automatically ex officio or you must submit an application. If you have already been entered in the electoral roll for previous European elections and have not moved abroad in the meantime, you will be entered in the electoral roll ex officio and do not need to submit an application. In all other cases, you must apply to be entered in the electoral roll. |

| | are at least 18 years old on election day, are not excluded from the right to vote and have had a residence or habitual abode in Germany for at least 3 months **or** |
| | have a contract of employment, employment contract or training contract as a captain or crew member for a seagoing vessel flying the German flag **or** |
| | are registered as a skipper of an inland waterway vessel entered in the German shipping register or as a member of the corresponding household **, or** are registered at the address of a prison or similar institution in Germany. |

| Verfahrensablauf | As a citizen of the Union, you can register on the electoral roll for the European elections as follows: |
| | You submit an application in accordance with Annex 2A of the European Electoral Regulations to the municipality responsible for you. The authority will decide on your application and send you a voter's notification or a rejection notice. |
