6\ a declaration as to whether and to which body an application for determination of equivalence has already been submitted.

7\ original registration certificate (not older than six months) of the main residence or proof of establishment or place of employment in North Rhine-Westphalia

The processing fee for registration is 260 euros.

and submit it with the necessary documents. The documents will be checked at the office and, if they are complete, submitted to the registration committee. The registration committee decides on the registration.
