| Erforderliche Unterlagen   | <ul style="list-style-type: none"> <li>• on receipt of social benefits: Proof of receipt of one of the social benefits mentioned in the original (notice of approval or certificate from the social benefit provider)</li> <li>• in the case of deafblindness: Current original medical certificate of deaf-blindness or Severely disabled person's pass with the mark "BI" and "GI" or Certificate from the pension office on the degree of hearing and visual impairment</li> <li>• if you receive assistance for the blind: Current notice of approval or certificate from the authority regarding receipt of benefits in accordance with § 72 of the Twelfth Book of the Social Code (SGB XII) or §27d of the Federal Pension Act (BVG)</li> <li>• in cases of hardship: the notice of rejection from the social benefits provider if the income limit is slightly</li> </ul> |
