#### Sachverhalt

Each time you register, you must inform the registration authority whether you have any other homes in Germany and, if so, which of these homes is your main home. When registering with the registration authority, you must submit written confirmation from your landlord or a person authorized by him/her (landlord confirmation). Your landlord or a person authorized by him/her can also confirm your move-in directly to the registration authority.

The confirmation from the landlord must contain the following data:

- 1. Name and address of the landlord and, if the landlord is not the owner, also the name of the owner,
- 2. date of moving in,
- 3. address of the apartment and
- 4. Names of the persons required to register in accordance with § 17 Paragraph 1 of the Federal Registration Act (BMG).

To register, you must complete and sign a registration form. You will receive written or electronic confirmation of your registration free of charge (official registration confirmation).

If, for certain reasons, you do not want your personal data to be passed on, in some cases you have the option of objecting to it being passed on. If the relevant requirements are met, it may also be possible to apply for a block on the disclosure and transmission of information.

### Erforderliche Unterlagen

- Registration form (may be provided by the municipalities for download or pre-filled)
- Identity card and/or passport as proof of identity and to change the apartment details
- Confirmation from the landlord or corresponding allocation feature

	<ul> <li>persons moving in from abroad: the last residential address in Germany (registration confirmation, date of moving in and out)</li> <li>Persons under guardianship: written power of attorney or guardian's identity card</li> <li>Persons who cannot appear in person: written power of attorney and identification documents of the person to be registered</li> </ul>
	Spouses, life partners and family members with the same move-in dates (move-in date and previous and current residences) should use one registration form. The competent authority may request the submission of further documents to verify the information (e.g. marriage certificate).
Voraussetzungen	If you have moved into an apartment, you must register with the registration office within two weeks of moving in.

Verfahrensablauf	Personal appearance at the responsible registration office is mandatory.

Frist	You are obliged to register with the registration office in your place of residence within two weeks of moving in. Late registrations can be punished with a fine.
