Teaser	If your ID card has been stolen, you must report this.
Volltext	As a German citizen, you are required to have an identity card from the age of 16 if you do not have a valid passport. Any theft of your identity card must be reported to the Citizens' Registration Office or the police. If you do not do this, you are committing an offense. You can apply for a new ID card at the same time as reporting it to the Citizens' Registration Office. Blocking the online ID card function: If you report the theft to your local Citizens' Registration Office or the police, the online ID card will be automatically blocked. • You can also have the online ID card blocked yourself by telephone. • Blocking ensures that any attempt to misuse the online ID function is detected immediately. After blocking, it is no longer possible to use the online ID function of your ID card or to have it read out on site. • You can only have the signature function blocked by the provider of your signature certificate.

Verfahrensablauf	As a rule, you must report the theft of your ID card in person. Your online ID card function will be automatically blocked after receipt of the report. Report the theft to the Citizens' Registration Office: • Make an appointment at the Citizens' Registration Office. Please find out about the regional options. • Your online ID function will be blocked immediately upon receipt of your report. • If you do not receive a prompt appointment to report the theft at the Citizens' Registration Office, report the theft to a police station as soon as possible Block the online ID card function yourself via the hotline: • Dial the blocking hotline 116 116, which is available 24 hours a day, 7 days a week. • Enter the blocking password that you received with the PIN letter using the telephone keys as soon as you are prompted to do so. • Your online ID card will be blocked immediately.
