- a system has been set up nationwide in Saxony-Anhalt, in particular the necessary collection structures are in place,
- for the system with all public waste disposal providers in Saxony-Anhalt there are coordination agreements or has been submitted to existing voting agreements,
- a system has the necessary sorting and recycling capacities,
- the system is financially efficient,
- the system has concluded a financing agreement with the Central Authority.

Kosten

Fees: EUR 2,500 – 25,000

Verfahrensablauf

Upon your request, the body responsible for waste management will grant authorisation to operate a system if the permit conditions are met.

The permit may subsequently be accompanied by ancillary provisions in order to ensure the conditions present at the time of granting the permit on a permanent basis, even during the operation of the system. The authorisation shall be publicly disclosed and shall be effective from the date of public disclosure.

After approval has been granted, you must ensure in Saxony-Anhalt a separate, comprehensive collection of all empty packaging from the private end consumer or in the latter. You must recycle the waste recorded in your collection system in accordance with the legal requirements. Several systems can work together to set up and operate their collection structures.

Bearbeitungsdauer

The processing time is usually two months from the submission of complete application documents.
