Volltext	<p>If you would like to work as a tax consultant in Saxony-Anhalt in the future, the official appointment by a Saxony-Anhalt Chamber of Tax Consultants is required.</p> <p>In addition to passing the tax advisor examination or aptitude test (or the exemption from the tax consultant examination), your personal suitability determines whether you are appointed for the activity.</p>

	<p>please contact the Chamber of Tax Consultants in which you passed your tax consultant examination or aptitude test or were exempted from the examination.</p> <p>**Chamber of Tax Consultants:**</p> <p>The Chambers of Tax Consultants are corporations under public law. One of the main tasks of the Chamber is in particular to monitor the fulfilment of professional obligations, to represent the professional interests of its members and to promote their further education and training.</p>
Rechtsbehelf	An action against the refusal of appointment as a tax advisor is admissible before the tax court.
Kurztext	In order to work as a tax consultant, you must be appointed by the Chamber of Tax Consultants. The appointment as a tax advisor must be applied for in writing, by means of an official form. If all the conditions for appointment are met, a certificate of appointment is issued. You will also be entered in the professional register.
