| Volltext                 | If you want to operate a private hospital, you need a<br>trade permit, a so-called concession. In this context, a<br>hospital within the meaning of trade law is an<br>institution that serves to heal and care for patients and<br>in which patients are treated as inpatients, i.e. also<br>accommodated and cared for.                      |
|                          | Only private, commercially operated hospitals need<br>such a permit. Public institutions and those operated<br>for non-profit, charitable or scientific purposes do not<br>need a permit. In contrast to these, the entrepreneur<br>who runs the private hospital has the intention of<br>making a profit from the operation.                  |
|                          | You can, but you don't have to be a doctor yourself. If<br>you are a doctor, a distinction must be made between<br>facilities that serve the exercise of your freelance<br>activity (e.g. the surgeon's clinic) and facilities that are<br>not directly related to the freelance activity and are<br>designed to make a profit.                |
|                          | The permit indicates whether it is used to operate a<br>private hospital, a private maternity hospital or a<br>private mental hospital (or a combination of these<br>facilities). Homes in which mentally ill or mentally<br>handicapped people are accommodated and only<br>occasional medical care is provided are not private<br>hospitals. |
