Teaser	If you are the organizer of a trade fair, exhibition, wholesale market, weekly market, annual market or special market, you can apply to the competent authority for an event permit.

authority for a permit. The effect of the determination is that you as an organizer are exempt from certain commercial obligations (e.g. travel fabric card, compliance with store closing times). Organizers are natural and legal persons. Cities also often act as organizers, mainly for weekly markets. If your market takes place in a public space, a special use permit is required. The competent authority will check your reliability during the application process.

## Erforderliche Unterlagen

- Certificate of good conduct for submission to an authority (document type 0)
- Excerpt from the Central Trade Register for submission to an authority (document type 9)
- Certificate in tax matters from the tax office of the place where you have lived or operated a business in the last 3 years
- Negative certificate from the insolvency court of those local courts in whose district you have had a residence or a commercial establishment in the last 3 years

If the event takes place in public space:

- Special use permit

Information that the informal application must contain:

- Date of the event
- Place
- Opening hours, e.g. Saturday and Sunday from 9:00 a.m. to 6:00 p.m.
- Event name, e.g. spring market
- Site plan with stalls, access roads from a bird's eye view
- Preliminary list of participants with the range of goods offered by the participants
- Blank contract concluded between the organizer and dealers

- personal reliability and the reliability of the persons entrusted with the management of the event
- Ensuring protection against hazards to life and health for participants
- There must be no danger to public safety and order

Kosten	The amount of the fee depends on the administrative effort.
Verfahrensablauf	<p>Once you have submitted the application and all documents are complete, the competent authority will check whether you meet all the requirements for granting the requested event.</p> <p>If you meet all the requirements, the event will be fixed.</p>
Bearbeitungsdauer	
Frist	You must submit the application and all supporting documents in good time before the start of the event.
weiterführende Informationen	
Hinweise	In principle, anyone is allowed to participate in a trade fair, exhibition or market. As an organizer, however, you can limit the event to certain groups of providers or visitors or exclude individual interested parties for objectively justified reasons. However, the selection among the candidates must be made according to factual, verifiable selection criteria. This includes criteria such as attractiveness, balance, versatility and novelty of the business operated by the applicant.
