Kosten	The amount of the fee for registration is determined by the Court and Notary Costs Act in conjunction with the Ordinance on Fees in Commercial, Partnership and Cooperative Register Matters. In addition, expenses for the public publication of the registration are incurred.
Verfahrensablauf	<p>The application must be submitted electronically to the registry court in a publicly certified form.</p> <p>After successful registration, you will receive a registration notification.</p>
