Volltext	If you are or will be working professionally, voluntarily or in any other way with children and young people, you will need an extended certificate of good conduct. The extended certificate of good conduct is intended to prevent the employment of applicants with a relevant criminal record in sensitive areas. This includes, for example, work as • Educators, • teachers, • school bus driver, • lifeguard, • sports coach. The extended certificate of good conduct includes convictions that are not included in the normal certificate of good conduct, e.g. because they were not sentenced to more than 90 daily fines. The extension only applies to sexual offenses and child and youth-related offenses such as "mistreatment of wards" or "violation of the duty of care or upbringing".
