Teaser	The construction and operation of plants require an immission control permit if they are likely to cause particular damage to the environment or endanger the general public.
Volltext	If you want to build and operate a plant which, due to its nature or operation, is particularly likely to cause harmful environmental effects or otherwise endanger the general public or the neighborhood, to significantly disadvantage or significantly harass, you need a permit from the competent authority. This also includes stationary waste disposal facilities for the storage or treatment of waste.

The notification of the approval notice to objectors may be replaced by a public announcement.</p>
