Volltext	As a health supervisor, you are responsible for monitoring hygiene standards in various facilities such as clinics or grocery stores. It is a recognised training occupation. Currently, training in Saxony-Anhalt is not possible. However, if you have already completed training in a health profession and have gained professional experience, you can complete further training as or as a hygiene officer in nursing. For this purpose, you will receive a certificate if you pass the final examination. With this certificate, you are entitled to work as a hygiene specialist.
