Volltext	<p>Many healthcare professionals opt for their own practice. Especially in the healthcare sector, the strict conditions ensure that excellent patient care is ensured.</p> <p>This applies to medical health professions and health professions, such as occupational therapy, physiotherapy, speech therapy and podiatry, e.B.</p> <p>If you want to work as a doctor, you must first be admitted yourself. This is done by the Association of Statutory Health Insurance Physicians.</p> <p>The following applies to all occupational groups in the healthcare sector: if you wish to practise your profession independently, you must register this with the competent health authority. Also in the future, you must announce all changes to your practice in a timely manner.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Your personal data, such as name, address, etc.</li> <li>• State examination, professional permit, permit to use the professional title</li> <li>• Academic degrees and titles awarded</li> </ul> <p>In addition, you must provide information on the area in which you would like to carry out the activity and when you would like to work independently.</p> <p>Many municipalities offer forms that you can use for registration.</p>
