This also applies if the costs of the funeral have been covered by public funds. If a surplus remains, the spouse, the life partner, the children, the parents, the stepparents, the foster parents, the grandchildren, the grandparents, the siblings and the siblings are entitled to receive one after the other if they lived with the deceased at the time of death in domestic community.</p> <p>In the absence of such beneficiaries, the surplus shall not be paid.</p>

This does not apply if the death occurred during a stay abroad. In this case, however, you can apply for aid.
