Which body is responsible for you depends on the following factors:</p> <ul style="list-style-type: none"> <li>• your foreign degree,</li> <li>• your place of residence or work,</li> </ul> <p>The competent authority compares your degree obtained abroad with the German reference degree. If no significant differences are found in this comparison, you will be certified as having full equivalence.</p> <p>If there is partial equivalence, in the regulated professions, the competent authority will give you specific measures with which you can take the found</p> <p>Be able to compensate for differences.</p> <p>"Regulated" means that you need recognition of your professional qualifications in order to be able to practice the profession or use the professional title.</p> <p>In the professions for which you do not necessarily need recognition (non-regulated), you will receive a notification in which the differences identified are described in detail. This allows you to apply directly to employers or to choose an individually suitable further training.</p> <p>The recognition procedure ends with either a positive or a negative decision.</p> <p>Partial recognition is not envisaged.</p> |
