Volltext	As measures for the prevention of diseases, health insurance companies offer spa stays. These include: • Mother-child cures (measure) • Father-child cures (measure) Children can travel either for their own treatment or (usually up to the age of 12 years) as an accompanying person. As a rule, the health insurance companies select a suitable spa clinic, but take individual wishes into account. A cure lasts three weeks. For this time, you do not have to submit leave to your employer. The permit is valid as a certificate of incapacity for work.
