Voraussetzungen	If you want to establish a branch office, you must meet all the requirements that are also necessary for a main branch. These include: • Permission to use the designation Publicly appointed and sworn expert or recognized expert of the Chamber of Engineers Saxony-Anhalt • the necessary equipment must be available before exercise. • You or a representative can be reached at any branch • You can exercise your duties as an expert or expert • Supervision by the respective chamber is ensured
