Teaser	If you have a temporary residence permit for mobile researchers and would like to continue your work at the research institution in Germany after the expiry of the time limit, you can extend your residence permit under certain conditions
Volltext	<p>The residence permit for the purpose of research for mobile researchers is a temporary residence title. You can apply for an extension of the residence permit if you want to continue your work at a research institution beyond the period of validity of your residence permit.</p> <p>Apply for the extension of your residence permit at the foreigners authority responsible for your place of residence no later than eight weeks before the expiry of the time limit.</p> <p>The same requirements apply to the extension of the residence permit for the purpose of research as to its issue. In particular, you should be able to present a hosting agreement or a corresponding contract with a research institution.</p> <p>In the case of an extension, your residence permit will be limited again. The residence permit for the purpose</p>

of research will be extended for the duration of the research project. However, the stay in the Federal territory may not last longer than one year in total.

As a rule, the residence permit cannot be extended if this was already excluded when the residence permit was issued or last extended.

Erforderliche Unterlagen

- Passport or passport replacement
- Existing residence permit
- Current biometric photo
- Hosting agreement or an appropriate contract with a research institution to carry out the research project.
- Tenancy agreement
- Proof of living expenses (incl. 3 proofs of income for the last 3 months)
- Proof of health insurance

Voraussetzungen

- You possess a recognised and valid passport or passport replacement as well as the valid residence permit for the purpose of research for mobile researchers according to § 18f Residence Act.
- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- You can secure your livelihood and health insurance cover from your income without claiming public benefits.
- You can present a hosting agreement or a corresponding contract with a research institution for the implementation of the research project.

Kosten

Extension of the residence permit for the purpose of research for mobile researchers:

- For a further stay of up to three months: EUR 96
- for a further stay of more than three months: EUR 93

Under certain conditions, a fee reduction or fee exemption may be considered.

Verfahrensablauf

You must apply for the extension of your residence permit at the aliens' registration office responsible for your place of residence.

- Depending on the foreigners authority and your

concerns, it may be possible to apply via the internet.

Find out whether your foreigners authority offers electronic application for the residence permit.

- If the application is only possible in person, arrange an appointment with the Aliens' Registration Office.
- During the appointment, your application will be accepted and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuing of the electronic residence permit (eAT).
- In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment for an interview at the Aliens' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the issuing of the eAT card.
- If your application is granted, the Aliens' Registration Office will arrange for the eAT card to be produced.
- After about six to eight weeks, you can collect your eAT card from the Aliens' Registration Office.

There are fees for the extension of the residence permit. The time and form of payment varies depending on the authority.

about 6 to 8 weeks.

Frist

- Extension of the residence permit: at the latest eight weeks before the expiry of your still valid residence permit for mobile researchers.
- Objection period: 1 month

Kurztext

- Residence permit for the purpose of employment
- Extension for mobile researchers
- Residence permits for the purpose of research for mobile researchers can be extended if their period of validity is due to expire in the near future and the activity at the research institution is to be continued.
- The extension must be applied for at least eight weeks before the expiry of the time limit.
- An extension of the residence permit for the purpose of research for mobile researchers is only possible if the prerequisites that existed when it was first issued continue to be met.
- In the course of the extension, the residence permit will again be limited in time.
- An extension is excluded if this was already ruled out by the Foreigners' Registration Office when the permit was first issued or when it was last extended.
- Depending on the Foreigners' Registration Office and the issue, the application can be made via the Internet or only in person.
- There are fees for the extension. The time and the form of payment vary depending on the authority.
- Responsible: Foreigners authority responsible for the applicant's place of residence.
