Teaser	You must submit the results of the continuous measurements annually to the responsible authorities for review.
Volltext	As the operator of a large combustion plant, gas turbine or internal combustion engine plant, you are obliged to continuously determine the emissions of certain air pollutants and certain operating parameters by means of continuous measurements in order to monitor the emissions of air pollutants and to assess proper operation. A measurement report on the results of the continuous measurements must be prepared for each calendar year and submitted to the competent authority for review by March 31 of the following year.
