The aim of the legal traineeship is to train you to practise the traditional legal professions. To this end, you will complete 4 compulsory stages and one elective stage.</p> <p>The preparatory service generally lasts 2 years.</p> <p>It ends with the second state examination in law.</p> <p>During the preparatory service you are a trainee lawyer.</p> <p>In Saxony-Anhalt, you can complete your traineeship in the following regional court districts:</p> <ul style="list-style-type: none"> <li>• Magdeburg</li> <li>• Halle</li> <li>• Dessau-Roßlau</li> <li>• Stendal</li> </ul> |
