Teaser	Do you operate a crematorium? Then you must have the air pollutant emissions from the facility tested and submit the measurement results to the responsible immission control authority.
Volltext	As the operator of a cremation facility, you are obliged to have the emissions of total dust, total carbon and dioxins and furans tested by a recognized expert body at regular intervals by means of discontinuous measurements (individual measurements) in order to monitor the emissions of air pollutants. A measurement report must be drawn up on the results of the measurements and submitted to the competent authority for review.

Frist	Individual measurements must be carried out by a recognized expert no earlier than three months and no later than six months after commissioning. The measurement report must be submitted within three months of the measurement being carried out.
