Kurztext	• Six times for children up to the age of 6, three of them in infancy. • first examination 6th to 9th month of life, second examination 10th to 20th month of life, third examination 21st to 33rd month of life • bis at the age of six, three further dental check-ups: The intervals of the early detection examinations are coordinated with the medical early detection examinations U5 to U7 in accordance with the children's guideline of the G-BA. • Children and adolescents from 6 to 18 years of age are examined once every six months. • From the age of 12, the examinations are entered in a bonus booklet (proof of entitlement to increased subsidies for dentures)
