## Sachverhalt

- State recognition as a counseling center is mandatory in order to be able to carry out pregnancy conflict counseling
- The establishment of a pregnancy conflict counselling centre can be applied for by independent institutions and municipalities
- Doctors can also be recognised as a counselling centre
- For recognition, certain conditions must be met, which must be proven when applying
- Public funding at a recognised counselling centre is granted under certain conditions
- Qualified staff for the counselling centre must be available and can be selected by yourself; staff must meet certain qualification requirements
