Volltext	<p>If you want to operate a standing catering business permanently, you must indicate this.</p> <p>You must also indicate in your display which operating mode it is.</p> <p>Operating modes are, for example:</p> <ul style="list-style-type: none"> • Snack bar / fast food restaurant • Public house • Dining industry • Tavern and catering industry • Pub and restaurant with regular music performances • Disco • Open bar area (beer garden) • Café • Bar • Discotheque • Service plaza • Kiosk • Shisha Bar • Department store restaurant. <p>You must also submit a complaint in the following cases:</p>

- operation of branches,
- operation of a dependent branch,
- the relocation of the permanent establishment,
- the expansion of the offer and
- the task of the operation of the permanent establishment.

You must also indicate in your ad whether you want to offer alcoholic beverages. They must indicate if the previous offer in the ongoing restaurant operation is to be extended to alcoholic beverages or to the offer of food to be prepared for consumption on the spot.

Erforderliche Unterlagen

- Proof of a requested certificate of good conduct of document type "O",
- Proof of an requested extract from the Central Trade Register of document type "9",
- information from the list to be kept by the insolvency court,
- tax clearance certificate.

You submit your notification to the competent authority.

The competent body shall forward the information without delay to:

- the competent building supervisory authority
- the place for food control,
- immission control,
- health protection and
- the protection of minors
- the tax office
- the Customs Administration.
