Voraussetzungen	<ul style="list-style-type: none"> • The forestry association must be a legal entity under private law • the forestry association must be suitable for working towards the sustainable adaptation of forestry production and the sale of forest products • The statutes must contain provisions on the task of the forestry association and its financing; • The forestry association must allow significant competition to exist on the timber market
