Teaser	Extension of a residence permit due to a ban on deportation.
Volltext	Your residence permit has been issued for at least one year. It can be extended if the prohibition of deportation and the other grant conditions are met. You must urgently ensure that you submit an application for the extension or issuance of another residence permit (e.g. a settlement permit) before the expiry of the period of validity of your residence permit. If the application is submitted in good time, i.e. before the expiry of the time limit, further residence is deemed to be permitted until the decision of the Foreigners' Registration Office with all subsequent effects (e.B. the right to exercise gainful employment). A late application (after the end of the time limit specified in the residence permit) can result in considerable legal disadvantages.

Kosten	Fee for extension of the residence permit: 93 Euro For minors: 46,50 Euro Exemption from fees for receipt of social benefits
Verfahrensablauf	As a rule, you must apply for the renewal of your residence permit in person - early before the expiry of the validity of your residence permit - at your competent immigration authority.  Make an appointment with the local immigration authority. You can also find out about the application process and which documents you must submit in which form on the respective website of the Foreigners' Registration Office.  If your application is granted, the Foreigners' Registration Office instructs Bundesdruckerei to produce the electronic residence permit (eAT) with a new validity date.  With regard to the duration of the procedure until the residence permit is handed over, please contact the competent immigration authority.
Bearbeitungsdauer	As a rule, when applying for an extension, you will be informed by the competent immigration authority of the duration of the procedure (about 6 to 8 weeks). Note: The residence permit is issued as an electronic residence permit.
Frist	Apply for the extension of your residence permit at your competent immigration authority in good time before the expiry of the validity. Please inquire about this at your local immigration office.
