Teaser	If you want to join your foreign spouse or partner in Germany, you can obtain a residence permit for family reunification if you meet certain requirements for this
Volltext	The residence permit can be issued if you and your spouse or partner have reached the age of 18, although the minimum age may be waived in certain cases. As a rule, you must prove simple language skills. With simple language skills, you should be able to communicate in a simple way in everyday life on German, for example, ask for directions, shop and imagine. There are several exceptions to the requirement of proof of language proficiency. If, for example.B the foreign person is in possession of an EU ICT Card blue card or mobile ICT card, then you do not have to prove any language skills. Information on other exceptions to language skills can be obtained from your competent authority. The residence permit for family reunification is a temporary residence permit. It is issued for the period of validity of the family member's residence permit in Germany - for at least one year. If the residence permit of the foreign person living in Germany is valid for less than one year, the residence permit is also issued for

the shorter period.

The granted residence permit for family reunification entitles the holder to pursue gainful employment.

Under certain circumstances, the Foreigners' Registration Office may oblige you to participate in an integration course. This will then be noted on your residence permit.

Erforderliche Unterlagen

- Valid passport
- Current biometric photo
- · Visa, if required
- Residence permit of the foreign person in Germany to whom the reunification takes place
- In the case of family reunification with the spouse: international marriage certificate as an officially certified copy or marriage certificate in the original language as an officially certified copy or marriage certificate checked by the German Mission Abroad for authenticity and correctness in the original language and in German translation
- In the case of family reunification with a life partner: Partnership certificate
- If applicable, proof of simple German language skills (A1 certificate)
- Proof of health insurance coverage
- Proof of livelihood security
- Proof of the living conditions (e.B. rental contract or purchase contract with information on the number of square meters of the living space)

Voraussetzungen

- You have a recognized and valid passport or passport substitute and, if necessary for entry a dedicated visa.
- There is no interest in expulsion against you.
- Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany.
- The foreign person in Germany has a valid residence permit, settlement permit, permanent residence permitEU, EU Blue Card, ICT card or mobile ICT card.
- You and your spouse or partner have reached the age of 18.
- You can prove simple language skills, if necessary.
- Your spouse or partner has sufficient health insurance coverage and financial resources to provide

Kurztext	 Residence permit for family reasons Issued for the reunification of the spouse to foreigners Spouses of a foreign person can obtain the residence permit for family reasons if the foreign person has a settlement permit, permanent residence permit EU, residence permit, an EU Blue Card, ICT Card or Mobile ICT in Germany or is entitled to stay in Germany as part of short-term mobility for researchers. In principle, the residence permit can be issued if both spouses have reached the age of 18 and sufficient living space is available in Germany. As a rule, the person moving in must prove simple language skills. The residence permit for spouse reunification is a temporary residence permit. It is issued for the period of validity of the residence permit of the foreign person to whom the family reunification takes place. Under certain circumstances, the Foreigners' Registration Office may oblige the person to participate in the integration course. Spouse reunification also applies to same-sex civil partnerships. Depending on the immigration office and concerns, the application is possible via the Internet or in person. There is a fee for issuing the residence permit. The timing and form of payment vary depending on the authority. Responsible: the immigration authority responsible for the applicant's place of residence
