Volltext	If you wish to carry out analyses in accordance with the Sewage Sludge Ordinance, you must apply to the competent authority to designate you as an analysis center. The designation applies to the whole of Germany.

Bearbeitungsdauer	The examination of the application for the designation of an inspection body must be completed within 3 months. The period begins upon receipt of the complete documentation. It may be reasonably extended once if this is justified due to the difficulty of the matter. The extension of the deadline must be justified and communicated in good time.
Frist	You must apply for the appointment of an inspection body before you start work.
