Teaser	If you are in direct contact with your research activity in search of a job or self-employment that meets your qualifications, you will be granted a residence permit for a maximum of 9 months.
Volltext	As a researcher, you have a legal right to a residence permit to look for a job. The residence permit will be issued to you for a maximum of 9 months in direct connection with your previous research activities. This makes it possible to find a job that matches your qualifications. The aim of the search can also be self-employment. This residence permit allows gainful employment without restriction.
Erforderliche Unterlagen	- Valid National Pass- Proof of secure livelihood (e.g. employment contract and payslips, bank statements, submission of a declaration of commitment by third parties)- Proof of health insurance- Proof of qualification (certificate of completion, certificate or certificate from your university on the successful completion of a course of study- 1 current biometric photo- Please ask the immigration authority responsible for you whether you need to submit further documents

Voraussetzungen	You have carried out a research activity in Germany, completed it and had a valid residence permit for the purpose of research (§ 18d or § 18e AufenthG). Other general requirements for granting a residence permit are:- a secure livelihood,- a clarified identity,- Possession of a valid national passport.
Kosten	Gebühr: 98€ Fixed costs: Fee EUR 98,00
Verfahrensablauf	You can only apply for a residence permit in person at the immigration authority responsible for your place of residence.- You submit the required documents in the original and pay the application fee.- The Foreigners' Registration Office checks whether the conditions for grant are met.- If all requirements are met, the Foreigners' Registration Office will record your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH.- As soon as the eAT is completed, it will be handed over to you by the Foreigners' Registration Office.
Bearbeitungsdauer	5 Woche(n) Depending on the local immigration authority (about 5 to 6 weeks). - The processing time may vary in the locally competent immigration authorities (about 5 to 6 weeks).
Frist	4 Woche(n) An interview 4 to 6 weeks before the previous residence permit expires is recommended. Application before the expiry of the current residence permit. An interview 4 to 6 weeks before the previous residence permit expires is recommended.
