Teaser	You can obtain a residence permit to work as a freelancer if you meet certain requirements.
Volltext	<p>You can obtain a residence permit for freelancers if you want to pursue a freelance activity in Germany. Freelance activities include the self-employed scientific, artistic, literary, teaching, educational or other self-employed professional activities according to § 18 paragraph 1 of the Income Tax Act (e.B. self-employed doctors, notaries, tax consultants)</p> <p>If necessary, you must present a professional permit. The professional license is a state professional license with which persons in Germany may work in a certain profession (e.B. health professions, lawyers). If you do not yet have a professional license, it is sufficient if you prove that the grant has been promised.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid passport or passport replacement</li> <li>• Visa, if this was required for entry into Germany</li> <li>• Current biometric photo</li> <li>• If necessary, permission to exercise the liberal profession or commitment to grant it</li> <li>• Proof of livelihood security (e.B. equity, blocked account, declaration of commitment)</li> <li>• Proof of your health insurance</li> <li>• Current registration certificate</li> <li>• If you have reached the age of 45: Proof of adequate retirement provision (e.B. proof of own assets,</li> </ul>

Voraussetzungen	<ul style="list-style-type: none"> <li>• You have a recognized and valid passport or passport replacement and, if necessary for entry into Germany - a suitable visa.</li> <li>• There is no interest in expulsion against you.</li> <li>• Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany.</li> <li>• You want to pursue a self-employed, freelance activity in Germany.</li> <li>• You have the necessary permission to carry out the freelance activity or you have been assured of the granting of the permit by the competent authority.</li> <li>• If you have reached the age of 45: You can prove that you have adequate old-age security.</li> <li>• You can secure your livelihood and health insurance coverage from your own resources without using public services.</li> </ul>
Kosten	<p>Issuance of residence permit: EUR 100,00</p> <p>Under certain conditions, a fee reduction or fee exemption may be considered.</p> <p>Hints:</p> <ul style="list-style-type: none"> <li>• Additional fees may apply for the issuance of the residence permit in the form of the electronic residence permit, which can also be used as electronic proof of identity.</li> <li>• The timing and form of charging and payment vary depending on the authority.</li> </ul>

accepted and your proofs will be checked (bring them with you to the appointment). Your fingerprints will be taken for the production of an electronic residence permit (eATCard).

- In the event of an electronic application, the Foreigners' Registration Office will contact you after receipt of your online application in order to make an appointment at the Foreigners' Registration Office if necessary. During the appointment, your proofs will be checked (bring them to the appointment) and your fingerprints will be taken for the production of the electronic residence permit (eAT card).
- If your application is granted, the Foreigners' Registration Office will arrange for the eATKarte to be produced.
- After about six to eight weeks, you can pick up the eAT Card at the Foreigners' Registration Office.
- The eATKarte must always be collected in person.

**Bearbeitungsdauer**

about six to eight weeks.

**Frist**

- The residence permit should be applied for no later than eight weeks before the expiry of your visa or current residence permit.
- The residence permit is issued for a limited period of time.
- Objection period: one month

**Rechtsbehelf**

An appeal against a decision of the Foreigners' Registration Office may be lodged with the authority specified in the decision within one month of notification of the decision. The objection can be filed in writing, in electronic form and for record.

If the objection is not complied with by the Foreigners' Registration Office, an action may be brought before the court named in the notice of opposition.

	<p>employment Issued to freelancers</p> <ul style="list-style-type: none"> <li>• Foreigners who want to work as a freelancer in Germany can obtain a residence permit if certain conditions are met.</li> <li>• If a special professional license is required for the exercise of the liberal profession, such as.B in the case of doctors, pharmacists, dentists and veterinarians, lawyers, tax consultants (e.g. admission, approbation), this must be available or at least the grant must be promised.</li> <li>• Depending on the immigration office and concerns, the application is possible via the Internet or in person.</li> <li>• There is a fee for issuing the residence permit. The timing and form of payment vary depending on the authority.</li> <li>• Responsible: the immigration authority responsible for the applicant's place of residence;</li> </ul>
