Teaser	After successful completion of your training in Germany, your residence permit for job search can be extended directly afterwards for a maximum of 12 months.
Volltext	If you have successfully completed a school or in-company training in Germany, you can be granted a residence permit to look for a job.  The residence permit will be issued to you for a limited period of time directly after your previous training. An extension is possible if the maximum period of 12 months was not used at the time of the first grant. If

	<p>you cannot find a job during this time, an extension is also excluded. You are then obliged to leave Germany.</p> <p>This residence permit allows gainful employment without restriction.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid National Pass</li> <li>• Proof of secure livelihood (e.g. employment contract and payslips, bank statements, submission of a declaration of commitment by third parties)</li> <li>• Proof of health insurance</li> <li>• Proof of qualification (certificate of completion, certificate or attestation of your training company or educational institution about the successful completion of an apprenticeship)</li> <li>• 1 current biometric photo</li> <li>• Please ask the immigration authority responsible for you whether you need to submit further documents.</li> </ul>
Voraussetzungen	<p>You must already be in possession of a residence permit for the purpose of looking for a job after successfully completing school or in-company training in Germany, which has not yet exhausted the maximum period of 12 months.</p> <p>In addition, you must meet the general conditions for obtaining a residence permit. These are in particular:</p> <ul style="list-style-type: none"> <li>• a secure livelihood,</li> <li>• a clarified identity,</li> <li>• Possession of a valid national passport.</li> </ul>
Kosten	Gebühr: 93€ - 96€
Verfahrensablauf	<p>You can only apply for a residence permit in person at the immigration authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• You submit the required documents in the original and pay the application fee.</li> <li>• The Foreigners' Registration Office checks whether the conditions for grant are met.</li> <li>• If all requirements are met, the Foreigners' Registration Office will record your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH.</li> </ul>

	<ul style="list-style-type: none"> <li>• As soon as the eAT is completed, it will be handed over to you by the Foreigners' Registration Office.</li> </ul>
Bearbeitungsdauer	The processing time depends on the workload in the locally responsible immigration authority.
Frist	Application before the expiry of the current residence permit. An interview 4 to 6 weeks before the previous residence permit expires is recommended. The residence permit, including an extension, is limited to 12 months.
