If your maiden name or name used before marriage or civil partnership was not a surname (married name or partnership name), you have the following options: • You can accept your birth name or the name used until the marriage name is determined. • You can prepend or append the following names to the married name: • your birth name or • the name used at the time of the declaration on the determination of the married name. • You can drop a companion name that precedes or is appended during the marriage.

The declaration takes effect as soon as it arrives at the registry office. You will receive a certificate of name change. The marriage register and the birth register will be updated.
