Erforderliche Unterlagen	The family court decides in the exercise of the so-called official investigation principle, which documents are required.
Voraussetzungen	<p>If a child's property is endangered and the parents with custody or one of the parents are unwilling or unable to stop the danger, the family court may issue orders. This is the case, for example, if the child's money has been embezzled.</p> <p>The procedure can be initiated at the request of a parent (a special form is not prescribed) or through official channels, in particular through reports by the Youth Welfare Office or reports from neighbours, educators or relatives.</p>
Kosten	<ul style="list-style-type: none"> • Court <ul style="list-style-type: none"> • where applicable: lawyers' fees • The family court decides on the bearing of costs at its equitable discretion.
Verfahrensablauf	<p>The proceedings at the family court are initiated ex officio, in particular by reports by the youth welfare office or reports from neighbours, educators or relatives.</p> <ul style="list-style-type: none"> • The family court determines the situation and may, for example, order the parents to submit a list of the child's assets and submit an account of the administration. <ul style="list-style-type: none"> • This list of assets must be correct and complete, the parents have to assure that. • If the list is not drawn up correctly, the family court may order that the register be drawn up by a competent authority or by a competent official or notary. • The order of the family court may also include, for example, (list is not exhaustive): <ul style="list-style-type: none"> • Withdrawal of the child's money only with the permission of the family court • Deprivation of custody (in whole or in part) • If parts of the custody of assets are withdrawn, a caregiver is appointed for the areas.
