Verfahrensablauf	You can register as a German abroad or a German abroad enter the voters' register for the European elections as follows let: • You submit an application in accordance with Annex 2 of the European Election Regulations to the last municipality in which you had an apartment or otherwise habitually resided before moving abroad. • If you have never lived in Germany, the application must be submitted to the district office Berlin Mitte. • The authority decides on the application and at the same time sends postal voting documents or a negative decision
