Teaser	Would you like to give up your existing permit for wastewater in an above-ground body of water and/or infiltration into groundwater? An application for revocation must then be submitted to the competent authority.
Volltext	A permit for the discharge of wastewater (rainwater, waste water, mixed water) into surface waters and / or via infiltration into groundwater can be revoked in Germany. An application may be submitted to the competent authority.
Erforderliche Unterlagen	The required documents (essentially justification) depend on the permission to discharge waste water to be revoked.
Voraussetzungen	The use of waters permitted with the permit will no longer be exercised in the future.
Kosten	For the administrative service "discharge of wastewater into waters revocation of the permit" an administrative fee must be paid to the respective federal state. The administrative fee is based on the respective national law provisions on administrative fees.

Bearbeitungsdauer	The processing time depends on the quality and scope of the submitted applications and documents.
