Teaser	As a professional with vocational training who has already received a residence permit to look for a job, you can apply for the extension of the residence permit up to a maximum total duration of six months.
Volltext	You have already received a residence permit for skilled workers to look for a job. This residence permit can be issued for a total of up to six months. If this 6-month period has not yet been exhausted, you can apply for an extension of your residence permit, provided that you continue to secure your livelihood. With the residence permit for job search, you can take on a trial job, which the qualification qualifies you to

Voraussetzungen	<ul> <li>may require less or further proof.</li> <li>In order to extend the residence permit, you must meet the same requirements as when the residence permit was first issued, i.e.:</li> <li>You have a recognized and valid identity document (for example, passport or passport substitute).</li> <li>You own qualified vocational training in Germany or an equivalent foreign professional qualification.</li> <li>The subject of your job search must be the exercise of a qualified employment for which you are qualified on the basis of your professional qualification.</li> <li>You have German language skills that correspond to the desired activity. As a rule, German language skills at least at level B1 of the Common European Framework of Reference for Languages are required.</li> <li>If employment in a regulated professional licence must already have been granted or promised.</li> <li>You can secure your livelihood and health insurance cover from your own resources without recourse to public services.</li> <li>The maximum period of six months for issuing a residence permit has not yet been exhausted.</li> </ul>

	Remark:Additional fees may apply for the issuance of the residence permit in the form of an electronic residence permit, which can also be used as an electronic proof of identity. stay of more than three months
Verfahrensablauf	<ul> <li>Find out whether your immigration authority allows you to submit your application online or has a special application form.</li> <li>If the application is only possible in person, make an appointment at the Foreigners' Registration Office. In the case of an online application, the Foreigners' Registration Office will contact you after receipt of your application to make an appointment.</li> <li>During the appointment, your identity and documents will be checked (please bring your documents, preferably original, to the appointment).</li> <li>If your request is granted, your fingerprints will be taken for the production of a new electronic residence title (eATKarte). The Foreigners' Registration Office commissions Bundesdruckerei to produce the eAT card. After completion, you will receive information and can pick up the residence permit at the responsible office. The eAT card must always be picked up in person.</li> </ul>

Frist	The application should be received by the Foreigners' Registration Office no later than 8 a.m. before your current residence permit expires. Duration: maximum 6 months The residence permit is issued for a

Hinweise	An extension of the residence permit beyond the maximum period of six months is excluded if no suitable gainful employment could be found within its validity. A residence permit for the purpose of seeking employment for qualified skilled workers with vocational training can only be issued again if the foreigner has resided abroad for at least as long after his departure as he previously resided in the Federal territory. The residence permit does not entitle the holder to pursue a self-employed activity.
Rechtsbehelf	<ul> <li>Appeal against the decision of the Foreigners' Registration Office</li> <li>Action before thecourt specified in the notice of opposition if the objection is not complied with</li> </ul>
Kurztext	<ul> <li>Residence permit for the purpose of gainful employment Extension of job search for qualified professionals with vocational training</li> <li>For the extension of the residence permit, the same conditions must be fulfilled as for the first issue of the residence permit.</li> <li>In the case of regulated professions, a valid professional licence is required (for example, doctors, pharmacists, dentists and veterinarians, lawyers, tax consultants).</li> <li>Residence permit is issued for up to six months. An extension is only possible if this 6-month period has not yet been exhausted.</li> <li>The residence permit entitles the holder to take up to ten hours of probationary employment corresponding to the qualification.</li> </ul>
